- 4. Citizen Comments: There were no comments received.
- 5. Consider and act on Christmas Decoration Contest (Novak) and Christmas Tree Drive-Through Event (Bedrick) To help unite the community during the pandemic, Council Member Novak had proposed the City hold a Christmas Decorating Contest. Homeowners who want to participate can complete a form. Volunteer judges will vote based on specific criteria, and a special sign will be posted in the winner's yard most of December. Offering another community builder, City Secretary Bedrick proposed a first ever lighted City Tree at City Hall. She said she may have two sponsors lined up to defray the costs and will continue efforts. She also proposed besides social media and the website that the City send postcard mailers to notify residents about the contest and the City Tree. According to Council Member Novak, the sign probably will cost less than \$100, and she may get a sponsor so there'd be no cost. Secretary Bedrick estimated postcard expenses at \$150 to \$200, plus postage. Mayor Warden said he liked the community events. He suggested Council consider \$400 for the contest and the City Tree.
